# **CONFERENCE FEES**

Participation as well as publication of abstracts and scientific articles is free of charge. Costs related to transport and accommodation are covered by the conference participants.

# **INSTRUCTIONS FOR AUTHORS**

Scientific papers will be published in the proceedings with ISBN.

The author is responsible for the originality, professional and formal correctness of the paper. It is not possible to publish a paper in the proceedings that has already been published in another periodical. The editors reserve the right to publish only original contributions that meet the content and all formal requirements of a scientific paper and have been recommended for publication by a reviewer.

Each active participant will receive a certificate of participation at the International Scientific Conference.

Papers should be written in English, Slovak or Czech. The title of the paper must be short and concise. The title should be followed by a 10 line abstract in English and Slovak/Czech. This is followed by 4-5 key words in English and Slovak/Czech, separated by commas.

The text of the paper must be written in MS Word (.doc; .docx). Papers in .pdf format will not be accepted. Tables, graphs and other supporting documents (e.g. figures and maps) must be submitted separately from the text. The Word editor must also be used to create tables, i.e. the table must be editable in Word. Charts must be submitted in MS Excel (.xlsx) and must contain original data. Images in JPGE or TIF format must be submitted in high resolution (min. 300 dpi). All graphs and figures must be numbered continuously in the order in which they are included in the text.

The paper template is available on the conference website. The length of the text is 8-14 standard pages, including tables, figures in the text or appendix tables and graphs. References and bibliographic citations (references to the literature used) should conform to the international standard ISO 690. The list of references is given after the text at the end of the paper.

The author is responsible for the originality of the paper and for its accuracy in terms of content and form. Furthermore, the author should provide the contact address of his/her place of work or residence, telephone number, fax number, e-mail address and the titles and addresses of all co-authors with ORCID identification.

The time limit for a single presentation in a section is set at 10-15 minutes (with the right reserved to the section chair to shorten the paper).

After the contact addresses, do not forget to indicate the project from which the scientific contribution is an output.
